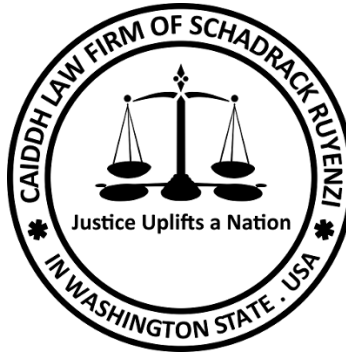

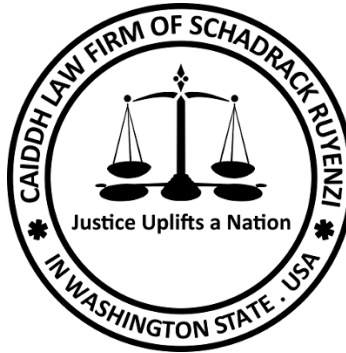

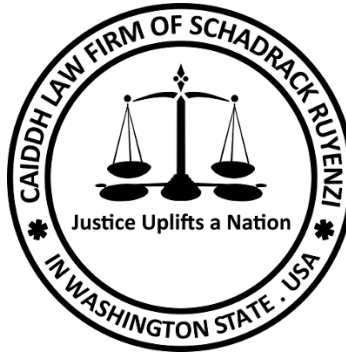

HIERARCHICAL STRUCTURE

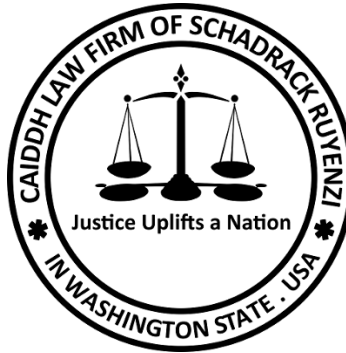

Trainees assist with administrative and legal tasks while gaining experience. Legal secretaries manage case files, appointments, and documents.



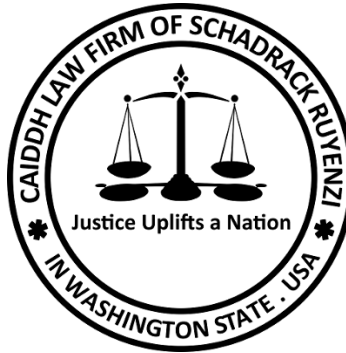
ALLOCATION OF RESPONSIBILITIES AND CASE MANAGEMENT
